#### PRIVACY POLICY

## 1. RESPONSIBLE

The International Organization New Acropolis is an entity dedicated to promoting socio-cultural activities aimed at discovering the varied and immense activity of man in the field of art, literature, science and any other manifestation of the human spirit.

## 2. PURPOSE

The purposes for which your consent is requested for the processing of your personal data are those indicated in the questionnaire that we ask you to complete, and which prevails over this Privacy Policy. In any case, we inform you that:

- A. We treat the information that the interested ones provide us for the sending of information on the activities that are carried out in each of their headquarters.
- B. We will keep the information you provide us as long as you do not request us to delete them.
- C. We will try, with your collaboration, to keep the data that we deal with, duly updated.

#### 3. LEGITIMATION

Except in the case that we expressly indicate, when obtaining your consent, the legal basis under which we carry out the processing of your data is the consent that you give us, for the purposes and uses that we have listed in detail in section 2. A previously indicated.

## 4. RECIPIENTS

In principle, we do not communicate to third parties outside the International New Acropolis Organization the personal data we deal with. If we were to do so, we would notify you in advance, and the entity that would receive such communication would request from you the consent that was necessary.

# 5. RIGHTS THAT ASSIST YOU IN THE DATA PROTECTION

We remind you that the current regulations recognize you the following rights

- To request access to your personal data, for any purpose, in particular to know if we are treating your data, with what purpose and with what legal basis.
- To request the rectification of inaccurate data or the deletion of the same.
- To request the limitation of the processing of the data, in certain circumstances, in which case we will keep them only for the exercise or defense of possible claims;

- To oppose the processing thereof, in certain circumstances and for reasons related to your particular situation, in which case we will stop treating your data except for compelling legitimate reasons or for the exercise or defense of possible claims; Y
- The portability of personal data that relates to you (not to third parties), that you have provided us directly, and that are subject to automated processing.

In the event that you exercise any of these rights, we will immediately proceed to execute what you order in this regard, without prejudice to the legality of the data processing performed until such date.
